

## NOTICE OF PUBLIC HEARING

Dear Sir and/or Madam:

RE: 1241 Harwood Street (formerly 1245 Harwood Street) - Proposed Heritage Revitalization Agreement and Heritage By-laws

On May 17<sup>th</sup>, 2011, commencing at 7:30 p.m., in the COUNCIL CHAMBER, THIRD FLOOR, CITY HALL, 453 WEST 12TH AVENUE, the Council of the City of Vancouver will hold a PUBLIC HEARING, pursuant to the provisions of the Vancouver Charter, to consider the above-noted Heritage By-laws. If approved, the Heritage Revitalization Agreement and By-laws would:

- designate the existing building at 1241 Harwood Street, which is listed on the Vancouver Heritage Register in the 'B' category as protected heritage property, and which will ensure the protection of the buildings from inappropriate alterations and demolition in the future;
- be in exchange for approval of bonus floor area for use in the proposed 18-storey residential tower on this site.

Anyone who considers themselves affected by the proposed by-laws can speak at the Public Hearing. Please register individually by telephone before 1:00 p.m., May 17<sup>th</sup>, 2011, by calling Terri Burke in the City Clerk's Department at 604-871-6399. You may register in person at the door between 7:00 and 7:30 p.m. before the Hearing. Please note speakers are requested to limit their comments to no longer than five minutes. You may also provide comments to the Mayor and Councillors by e-mailing <a href="mayorandcouncil@vancouver.ca">mayorandcouver.ca</a> at least a day before the Public Hearing. Staff will ensure Council receives all correspondence before the matter is considered.
